If you will be using your own transport company for shipping, please note that shipment must be sent DDP (Delivery Duty Paid). Shipment must be US Customs cleared by your transport company and delivered to the Advance Warehouse. GES will not act as Importer of Record (IOR) or Ultimate Consignee regarding exhibitor freight and will not provide a Power of Attorney to any entity regarding exhibitor freight.

\*All *inbound* carriers must check into the warehouse by 2:00 PM to be guaranteed same day unloading. Loading docks become busy and cannot always accommodate late afternoon arrivals due to heavy congestion

**All exhibit materials must be sent in advance to the GES warehouse. Renasant Convention Center does not have the capabilities to receive large shipments nor does it have adequate storage space for exhibitor materials. If you plan to ship direct to show, please contact GES in advance to obtain instructions and contact information for the venue, as it will have to be arranged directly with Renasant Convention Center.**

**POST SHOW PICK UP:**

All exhibit materials will need to be shipped out direct from show site. If you use a carrier other than the official show carrier and they fail to pick up your shipment at showsite, your shipment will be re-routed to the destination on Bill of Lading or sent to GES Warehouse.
